Kate - maybe have a new service position to have a newcomer greeter,

Motion: Kate 2nd: Devi Present: 25 Pass: Y: 18 N: 0

Kate E and Patsy B: I propose that we rescind our membership in the Virtual InterGroup and that we remain a stand-alone meeting.

Discussion

Patsy - This was not us,

Kate - I was all in favor at first, but we will have all the access I thought we'd have, One issue was only on the phone, a lot of committee reports, a lot of talking, a lot of arguing

Ann - question - try another one?

Patsy - no be a stand alone meeting

Jean - over committed and arguing so I like simplicity

Maria - important to hear other voices, bring back what is being discussed in the larger OA

Devi - important to be part of an intergroup, OA footsteps very organized Good to be accountable to the greater whole

Karen K - do not want to be part of a phone intergroup, but I do want to be part of an intergroup

Patsy - I would agree to split this up

Dianna - We bring something to the table too, I think it would be good that our voice be heard

Randi - yes, let's get out of this one

Ronna - my question is - a lot of discussion before, did someone volunteer?

Patsy - no, we don't have anyone

Robin - let's keep an open mind, we might find a another one

Kathryn Louise - I thought Gloria was helping with this

Patsy - she is not attending this meeting right now

Rescind membership

Motion: Patsy 2nd: Kate Present: 23 Pass: Y 15 N : 2

Jill M-B: To change how we ask for volunteers to read the "For Today". Reasoning for the suggestion: * It's awkward as the Chair to have to pick someone * As a fellow in the meeting it can feel awkward at times too * As someone who likes to volunteer to read now & again, if you put your hand up too soon the Chair thinks you're wanting to make an announcement Details/Thoughts: A) In the script at #10 "Information & Announcements" add the following (or something like it) to first bullet: This meeting is held every day at 8 am Eastern Time. We read from the "For Today" book. Each day we look for someone to do service and be our reader, and when possible, we like to hear from different people. You do not need to have the book because we'll put it on the screen. If you'd like to be considered to read today, please chat to [NAME] our [ROLE] now. A reader will be chosen shortly. B) And then I'd go back to the remaining bullets as they were starting with "Our Group Conscience Meetings are held..." C) Who do we say to chat interest in reading to? In my humble opinion, I think the Chair is super busy at this point in the script so I would suggest maybe Tech Host or Waiting Room Admit Person. D) Whomever is chosen to chat to would give people a little bit to chat them (a couple bullets worth of time) and then select someone. They'd then chat the name to the Chair. E) Depending on what the outcome of the suggestion is, we could also have the copy/paste person add to the chat (at the same-ish) time: Would you like to read the "For Today" passage (no book needed, we put it on the screen)? If yes, please chat to [NAME] our [ROLE] now to be considered. A reader will be chosen shortly. Discussion

Ann - good suggestion - shouldn't go to the chair,

Mary - adds more complications to the process, let's keep it as simple as possible Doreen - script is very long, let's just pick someone before we start

Ronna - good suggestion, I thought the chat was closed, but maybe it could be a sign up position

Karen K - doesn't take long to choose someone, chat is distracting, if it's not broke, don't fix it.

Kathryn Louise - not choose in pre-meeting, wouldn't get new people, it's fine the way it is.

Devi - Like how it is

Robin K - agree with Karen, a lot of the people don't go to the before meeting Jill - length of the script is not part of this, the complication of it was not part of it
